Government Incentives

There are Government programs in New South Wales, Victoria and South Australia that offer financial incentives to businesses to reduce their consumption of electricity through energy-savings initiatives, such as replacing fluorescent lights with LED panels.

Each State has its own raft of requirements that need to be met, for compliance, testing, accreditation and auditing.

Corporate Lights will apply for energy savings certificates on your behalf, and we'll manage the process so you reap the benefits without having to do the paperwork. These programs are available for a limited time so you should take advantage of them while they are available.



5 Year Warranty

All Corporate Lights LEDs come with a 5 Year parts and labour warranty and are rated to exceed 50,000 hours of use.

Tax Deductible

Small businesses with a turnover of less than \$2 million may be able to claim an immediate tax deduction for LED Lighting upgrades costing less than \$20,000 ex GST and acquired by 20 June 2017. Please speak with your accountant to confirm your eligibility.
